- Having considered Decree no. 17 of 9<sup>th</sup> January 2008 regarding the admission of third-country nationals for the purposes of scientific research
- Having considered the University's Regulation on Research grants "Regolamento delle borse per lo svolgimento di attività di ricerca"
- Having considered the D.G.R. (Decree of the Regional Board) n. 11/2018
- Pursuant to art. 80 paragraph 4 of the "Regolamento di Ateneo per l'amministrazione, la finanza e la contabilità" (University regulations for administration, finance and accounting);

### HEREBY DECREES

To publish a selection announcement for the awarding of no. 1 research visiting fellowship as advanced scholar at the Department of Political Science, Law, and International Studies of the University of Padova under the supervision of Prof. Alessandra Pietrobon, Research Project Supervisor.

The research fellowship is addressed to professors or researchers coming from international academic institution.

The research fellowship shall last 2 months.

The research fellowship shall be for a total gross amount of € 8.000,00, financed by ESF DGR n. 11/2018 and will be paid in deferred monthly instalments.

The Research Fellowship Holder must carry out the following research activity:

The senior visiting fellow will carry out a specific research in Veneto for two months, aimed at ensuring the success of the project and at the same time supporting and leading the research fellow. The primary objective of the intervention is the transfer of know-how and specific skills from the visiting Fellow to the research Fellow, and therefore to the partner companies. This is the added value that it will bring to the project. The senior visiting fellow shall come from an international university and possess a long-time experience in the field of European Union law, in particular competition law, and energy law. Besides, an energy strategy at national and regional level cannot ignore the evolution taking place in Europe and the challenges that the EU and its Member States have to face. The Fellow will pay particular attention to the analysis of the rules governing access to the "dispatching services market". The partner companies have in fact already identified this as an area for which it is necessary to verify the compatibility/adequacy of the Italian domestic legislation with respect to European Union law.

The period of stay of the visiting fellow both at the partner companies and the University of Padova will facilitate the joint research work, the exchange of knowledge, the analysis of good practices and the deepening of the results achieved in a comparative perspective, with particular regard to the legal order of the State of origin of the visiting Fellow. In perspective, it will make possible the development of new shared projects. It must be emphasized that the contribution to the project of the visiting Fellow will not be time wise limited to the two months of the scholarship. The mutual exchange, the transfer of knowledge between the research Fellow and the visiting Fellow will characterize the whole project, even in itinere.

At the end of the visiting period, the Research Fellowship Holder must submit a report on the activities carried out during his/her cooperation and on the achieved results.

## ADMISSION REQUIREMENTS

- PhD

The eligibility of qualifications awarded abroad will be verified by the Selection Committee.

For candidates who have an Italian University degree:

- Dottorato di Ricerca

### Required skills:

Long-time experience in the field of European Union law, in particular competition law, and energy law. Command of the English Language.

### Incompatibility

The fellowships within this announcement may not be combined with:

- other research grants;
- other fellowships. Mobility fellowships awarded by Italian or foreign institutes for the same specific research activities required by this announcement will not be incompatible.
- For self-employed and employed candidates, compatibility with the grant shall be determined by the Research Project Supervisor.
- Research Fellowship cannot be awarded to anyone who is married or related to, or has an affinity with, up to and including the fourth degree of kinship, a professor or researcher working at the Department of Political Science, Law, and International Studies, the University Rector, the University Director General, or a member of the University's Board of Governors.

If using this method, the application must be sent:

- through certified e-mail (PEC). The application must be signed and any documents for which a traditional signature is required must carry the applicant's digital signature.

- through certified e-mail (PEC). The copy of the application must have an original signature, together with a copy of the applicant's identity document. Any electronic documents that are required to have a traditional signature must be sent in simultaneously with the application. Only scanned copies shall be accepted, through his/her personal certified e-mail (in accordance with the Decree of the President of the Council of Ministers (DPCM) dated 27/9/2012 together with all the relevant documentation).

If using certified e-mail, documents must be sent in a fixed and not directly editable format without macros or executable codes, preferably in PDF. Documents must not exceed 1 MB.

On the envelope or in the certified email subject line it must be written: "Selection Announcement for the Awarding of Research Visiting Fellowship – Project: *“La promozione delle energie rinnovabili nelle imprese venete: strumenti e tecniche normative a livello europeo e realtà locale”* at the Department of Political Science, Law, and International Studies.

Any additional documents must be included with the application and submitted by the Selection Announcement deadline.

Documents submitted at a later date will not be accepted.

Neither shall the University accept any liability for postal, IT or third-party errors, nor for errors due to chance or force majeure.

### **Selection procedure**

Candidates' applications shall be evaluated by a Selection Committee that will be nominated in accordance with the "Regolamento delle borse per lo svolgimento di attività di ricerca" of the University of Padova (Regulations Governing Research Fellowships), on the basis of their qualifications.

Prior to assessing candidates, the Selection Committee shall establish the maximum score, the criteria and the procedure to be used in the evaluations

At the end of the selection, the Selection Committee will submit a report to the Head of the Department for approval.

Upon verification of the report, the Head of the Department decrees the ranking order and the awarding of the grant.

The administrative office of the Department that issued the selection announcement shall notify the successful candidate.

The winner must accept the award within ten days of notification. If the winner does not comply within

said deadline, the winner will forfeit the right to the research fellowship and the fellowship will be awarded to the next eligible candidate, according to the ranking order.
